

## Terms and Conditions of CU eShop Monthly Discount Promotion ("Promotion"):

- 1. Unless otherwise specified, the Promotion only applies to the principal and supplementary cardholders of Dah Sing Credit Cards ("Eligible Cards") issued by Dah Sing Bank, Limited ("Bank") ("Eligible Cardholders"). UnionPay Dual Currency Credit Card RMB account, Cash Card, Corporate Card, Purchasing Card, Business Card, Gift Card, Private Label Card, "Smart Choice" Balance Transfer Account and Cash Conversion Plan Account are not eligible.

- 11. In case of fraud, abuse, reversal or cancellation of transactions in respect of which the Offer is awarded, the Bank reserves the right to debit the equivalent amount of the awarded Offer from the relevant Eligible Cardholder's Eligible Card account without prior notice.

- 15. In the event of discrepancies between the Chinese version and English version of these Terms and Conditions, the English version shall prevail.
