### **Branches Re-opened for Normal Operations**

The following branches are re-opened for normal banking services from 10:00am to 5:00pm on Mondays to Fridays:

**Hong Kong Island: Queen's Road East branch**

**Kowloon: Telford Gardens branch**

**New Territories: Fanling, Kwai Fong, Shatin branches**

### **Temporary Closure of Branches**

The following branches will be temporarily closed from today until further notice to conduct thorough cleaning and disinfection to ensure a safe environment for its customers and staff.

**Hong Kong Island: Fortress Hill branch**

**Kowloon: Jordan, Yaumatei branches**

**New Territories: Maritime Square, Ocean Walk, Sha Tsui Road branches**

For extra precautionary measure, staff members in the above temporarily closed branches will be asked to take the COVID-test and to return to work upon confirmation of negative results.
